Bits from the Board

Vision Statement Development

The Envisioning Team presented a draft Vision Statement to the Board for feedback at our most recent Board meeting. We are trying on for size what the UU Congregation of Phoenix did to see how it fits us:

as a reflection of our key values (radical hospitality and creating a more multicultural community as we care for each other as we care for the world) and to possibly create a branding and marketing tool. There was robust discussion and we're testing the waters with the six words above for our next publicity postcard, and we're not done yet. Look for further updates to come!



Shared Ministry

At the November 3 service, I spoke representing the Board and Beth Ogilvie spoke representing the Committee on Ministry (COM) as to our impressions of "Shared Ministry" and how we minister to each other. We do a lot! And it became very visible to me as to the many ways we make church together. It was uplifting to be reminded of how many gifts we have to share.

Additionally, we were honored to have Rev. Dr. Jonipher Kwong on November 10 to co-lead worship and to facilitate a thought-provoking workshop on "Shared Ministry". Part of the workshop included a case study regarding the "Nominating Committee of Anytown" with small group responses to questions about the scenario. Many great insights and suggestions were generated and I've captured notes from the workshop. Email me if you'd like them and I'll be glad to pass them along.

Fiscal Sustainability

On November 17, we held a congregational discussion about our long term financial stability. Because of the stellar efforts of our finance committee (Keith Lewis) and our Board treasurer (Marilyn Mosher), we now have an effective tool to project out the state of our finances up to 10 years or more. Based on conservative assumptions and the current balance of working capital, if we change nothing, we will use up our reserves

and run out of money by 2025. A second scenario was presented and supported by the Board that takes the difficult step of reducing the hours for the Director of Religious Education (DRE) from half time to quarter time starting next July thereby significantly changing our approach regarding youth religious education to a model more geared toward family ministry. By taking this step, our reserves may last for an estimated 10 years – until 2029 – if there are no changes. This gives us a stronger chance and enough time to successfully build additional revenue sources and our long term sustainability. This long term, multi-year effort will involve the formation of a task force to research and develop strategies with ongoing opportunities for the congregation to provide input and ideas. While this is a significant challenge for our congregation, it also offers us an opportunity – especially if we have time on our side. Many in attendance expressed gratitude to be able to see the forecast early so that we can take steps now to develop solutions. Deep thanks to Marilyn and Keith and to those who attended the congregational discussion.

You are me


We are one.

In case you were wondering, Unitarian Universalists do have their own winter holiday, Chalica!


Chalica is a week-long celebration of the Unitarian Universalist Principles. The holiday first emerged in 2005 out of a wish to have a holiday that highlights the UU 7 Principles. The light symbol of this celebration is a chalice, which is a cup with a foot and stem.

Chalica begins on the first Monday in December and lasts seven days. To celebrate Chalica, Unitarians light the chalice one candle each day. Each day is spent reflecting on the meaning of the day's principle and a good deed that honors that principle.



Mistakes and Miracles

Congregational Read




I've joined others in reading *Mistakes and Miracles: Congregations* on the Road to Multiculturalism by Nancy Palmer Jones and Karin Lin. Described as a "powerful and necessary book," I find it to be engaging and a sneak peak into how congregations committed to multiculturalism are walking on this journey.

While I've only read about half of the book so far, I truly appreciate the thoughtful and pragmatic definitions of critical terms and how the authors so honestly present their view-points in such a humble and authentic way. They took great care to listen deeply. It was also so very important to them to have what they are presenting reviewed by each of the sources as a way of modeling accountability and cultural humility. I particularly like the calling out and naming the twelve "Common Threads" that are involved with doing this work. These can become tools in our tool box as we also join the journey towards multiculturalism.

Reading this book in a group setting, and having great conversations around what we read, has been a great experience in learning together and I highly recommend it. Please consider joining us even if you've only read some of the book. I'm sure you'll find the discussions rewarding!

Save Taxes by Donating if You're Over 70

If you are over 70 1/2 and taking mandatory minimum distributions from an ordinary IRA, you can donate to the church with pre-tax dollars by making a Qualified Charitable Distribution (QCD). This is better than a deduction because it reduces your Adjusted Gross Income (AGI), and that not only reduces your taxes, it helps with those percentages used to calculate thresholds for various other deductions. The secret is to have the company that holds your IRA make the check out to the church. They can mail it to you (so you can check it and make a copy before passing it on to the church) or they can mail it to the church directly. You can give up to \$100,000 per year this way. Please check with your tax specialist to see if you are eligible, and which is better for you, QCD or itemized deduction.

Details

As Kathleen Pender's 12/16/18 "Net Worth" column in the SF Chronicle said, "Donating from an IRA gives you a tax benefit equal to – and in almost all cases better than – what you would have gotten had you taken the donation as an itemized deduction.

"This type of transfer, called a qualified charitable distribution or QCD, reduces your adjusted gross income (AGI). 'Lots of other tax benefits, credits and deductions are based on AGI,' said financial expert Ed Slott, a CPA and author of several books on retirement. 'Reducing your AGI may reduce your Medicare premium surcharge, the amount of Social Security that's taxable, and it could increase your medical deduction.' Itemized deductions reduce your taxable income, but not your adjusted gross income, so they don't have those same benefits.

"This type of donation, also called an IRA charitable rollover, counts toward the required minimum distribution that people older than 70 1/2 must take from their regular (not Roth) IRAs each year, as long as they make the donation by year end. But it's not limited to your required distribution. Each person older than 70 1/2 can donate a total of \$100,000 per year to one or more charities this way."

"Robert Peterson, a retired Santa Clara University law professor, says 'That's probably the way I'm going to do my giving going forward because I can't think of any reason not to. Most people are slightly annoyed about having to take a required distribution because it's taxable. When you make a qualified charitable distribution from your IRA, it's almost like the government is giving you a matching gift."

Tax time hint: The 1099-R from your IRA holder will not separate QCDs from taxable withdrawals, so your total withdrawal amount will appear in box 2a. To calculate the taxable amount, take the figure in box 2a and subtract the total of your QCDs from that account for the calendar year.


