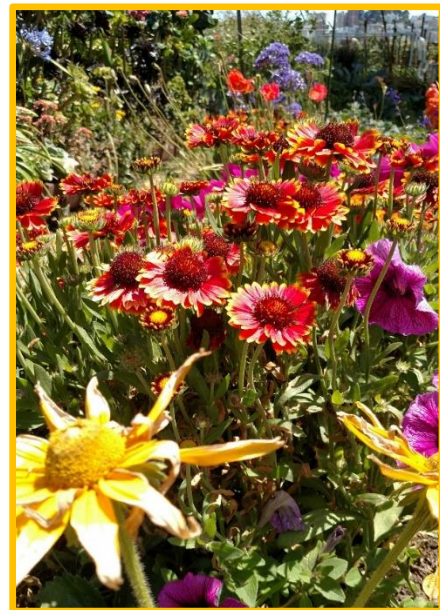

## **Showing of the Movie, "Trapped"--**

This is the new documentary film about some of the 288 laws passed by right-wing legislators since 2010 restricting the operation of abortion clinics and the effects they have had on the abortion providers and the women who need their services.

Many of you were among the 20 people present when the film was shown at the Castro Valley Library on Sunday, June 26. It was followed by a discussion of the film and people's reactions to it, facilitated by Mileva Lewis. The film was at times disturbing and at times tugged at the heartstrings for the women whose pregnancies had resulted from violations and who, because of the burdensome laws, were not able to obtain an abortion. At times the stories were a stark reminder that even though Roe v. Wade is still the law of the land, the fight over this issue is never finished.

The Committee was excited to learn that on Monday, June 27 the U.S. Supreme Court had ruled in a 5 to 3 decision that one of the laws, HB 2 in Texas, imposed an undue burden on the constitutional right of women to obtain an abortion.

This felt almost personal to some of us, since the clinics, providers, and women using their services in Texas were a significant part of the film, which included interviews with people whose appeal all the way to the Supreme Court resulted in the law being overturned. The effects of the court ruling go far beyond Texas because it will also apply in several other states which have passed similar laws. We're grateful that we haven't had to deal with such laws in California.

## **Fracking and other oil extraction methods banned in unincorporated Alameda County--**

Why does this matter? Fracking and other high-intensity operations to extract oil from the earth result in much more global warming than burning gasoline, diesel fuel, and natural gas. They often also result in more contamination of clean air and water than conventional oilfield operations.

Some on the committee have been working toward an ordinance banning fracking and other extreme extraction methods for oil and gas in Alameda County for over two years. The Planning Commission voted to ban these methods last month, and the Board of Supervisors followed suit on July 19. Recent Interim Minister Rev. Joy Atkinson starred in the documentary movie, "Faith Against Fracking," which was part of this campaign.

The passage of the ban on fracking and other extreme extraction methods will free the Committee's time, so that members can focus on other critical aspects of climate change in the months ahead.

## What is the Safety Committee & Why Should I Care by Beverly Powell

You may have heard around church a mention of a new (yes, another!) initiative at Starr King. This new “thing” is the Safety Committee, technically a sub-committee of Pastoral Care. The Safety Committee (SC) came about in an effort to better serve the people of the church. If you look at the Unitarian Universalist Association (UUA) website, ministering to the needs of a congregation goes beyond cards, calls, meals, and visits in times of need. It can include helping to create a “Safe Congregation,” which is an active effort to anticipate and solve problems before they happen or at least before they become troublesome.

Below are some of the answers to questions that have come up:

1. **How did the idea of a SC arise, and what is its purpose?** Since late last year, the Pastoral Care Committee has been working with the Board of Directors to find ways to improve congregational safety to further minister to the needs of church members. The SC was set up as a sub-committee of Pastoral Care to evaluate and address recommendations made in a November 2015 “Safety Check,” conducted by member and retired Fire Chief Mike Preston. Mike has given generously of his time and expertise to help the church come up to date and up to code in our building and its facilities. Changes recommended by Mike are in some case required by law, and all are intended to improve physical safety of our congregation, guests and visitors. In January, the recommendations were presented to the Board. The Board agreed that Pastoral Care should expand its ministry to include follow-up on many of Mike’s points.

SC was set up to focus on issues like data security, fire codes, safety signage, training on medical emergencies, installation of a new Automated External Defibrillator (AED), and other building, data, training and procedure details. All of these things impact the safety of the congregation and building and property security. The process is just beginning, and that is a key reason why it makes sense to have a few people meet regularly on the topic of Starr King Church safety.

2. **Is that the group that made the chairs move at the back of the Sanctuary?** Yes, and thank you for your flexibility! Mike Preston’s view, as a proxy for Fire Department officials, was that the width of the aisles in the Sanctuary specifically was a problem. Wide aisles make easy exit in an emergency, and it is a code issue. Under Hayward ordinances, side aisles must be a minimum of 36 inches wide, and the center aisle should probably be wider, because people often walk side-by-side up and down the center aisle. A minimum width of 36 inches is required by code for all passage-ways in buildings open to the public. At the rear of the Sanctuary, the back wall should be kept clear of chairs for easy exit in an emergency.

The Committee realizes various groups use the perimeters of the Sanctuary before, during and after services, and that the new set up recommended for code compliance may not YET be perfect for everyone. Committee members have already listened to comments from a number of people and will be reaching out for more. All affected committees, such as, Worship, Membership, Ushers, Religious Exploration, Building and Grounds, and others are asked to provide feedback to interact about this and other issues. The Safety Committee is open to everyone’s ideas within the parameters the regulations set.

If YOU have any feedback on this issue, please contact any member of the SC. The Committee members are Chairperson, Georgia Gruver; Representative of the Board Bob Britton; and new Starr King Church member Beverly Powell. All are in the directory!

3. **What is happening?** There is an ongoing effort following up on building security and safety matters cited in Mike’s Safety Check. Additionally, we have already completed a data security analysis in response to a specific recommendation in the safety check to review the current state of our network, email, and computer hard drive security. Overall data security is in great shape.

The most immediate NEXT priority is to train some members of the congregation on the new AED device. We will install one of these devices in the church as soon as training is completed. Mike Preston negotiated for the AED machine to be provided at no cost to us. Having this life-saving piece of equipment is a real plus to our church's safety.

**The two training classes for AED proficiency have been scheduled for Fellowship Hall on the following dates:**

- a. **Saturday, July 23 from noon to 4 pm**
- b. **Tuesday, August 9 from 6 to 10 pm**

Twenty people have already signed up for the available spots in these first two AED classes. If you are interested in this or other emergency medical training, please contact Georgia Gruver to be placed on a list for future classes. Also, by requesting or receiving AED training you also indicate willingness to take AED refresher classes required by law. These are given every two years. Other classes on CPR, First Aid, and response capability for other medical emergencies are planned. These classes will also be run on church premises, and spots in the classes have been filling up. If you have not yet signed up, it is not too late!

Other pressing matters The Safety Committee is researching and/or planning include:

- Exit maps for the building, so that leaving in the event of an emergency is as efficient as possible;
- Improved building and property perimeter security;
- Information for the congregation on safe use of email and other communications media as we interact with the Starr King website and email server;
- Education, training and drills on the sorts of emergencies that could affect our congregation, such as medical emergency, fire, earthquake, etc.

In today's complex environment, there are a multitude of risks to our church property and congregation. Many of these are outlined on the UUA's and its insurer's (Church Mutual) websites. The SC's approach to safety and security is based on specific risks that might apply here, based on our building, our surroundings and, our choices as a congregation.

4. **How do I participate?** If you are interested in medical emergencies training, please sign up now by emailing Georgia Gruver at [gggruver@comcast.net](mailto:gggruver@comcast.net). Even if the class you are interested in is taken, there will be a waiting list.

If training for one of these medical emergencies is not for you, the first big impact on you might be a fire drill later this year. Several other things have to be in place before that happens, including building exit maps. There will be a meeting giving everyone some important background on fire drills, complete with written reference materials. After that, we will set up a "live" drill.

Churches are increasingly faced with the same harsh realities and risks that businesses and government entities have dealt with for years. Using available resources from the UUA, its insurer Church Mutual, and other institutions and groups more experienced than Starr King, the SC is working hard to minister to and protect our fellow members and our sacred places by mitigating risks based on analysis of exposure to specific risks. The committee needs everyone's help, cooperation, and feedback about the church's overall safety and security.
